## **SHORT TERM TENDER NOTICE INVITING E-TENDERS**

Online bids on percentage rate (as specified in tender document) basis are invited for the following work on the dates as per the schedule mentioned below in the office of Director, Haryana Police Academy, Madhuban, Distt. Karnal on the prescribed form. The electronic tender forms are available at website <http://etenders.hry.nic.in> for downloading and uploading / submission of bids through e-tendering.

- 3) The detailed tender notice and DNIT can be seen in the office of Director, Haryana Police Academy, Madhuban, Distt. Karnal or downloaded from website <http://etenders.hry.nic.in> or [hpaharyanapolice.gov.in](http://hpaharyanapolice.gov.in). The price bids of only those tenderers shall be opened who have deposited requisite Earnest Money and cost of the Tender Form through online (RTGS/NEFT) in the account of **HPA DEVELOPMENT FUND** in account No. **82542200005219** in **SYNDICATE BANK** at **Police Complex, Madhuban** having IFSC code: **SYNB0008254**. Technical Bid documents will also be submitted online. No other mode of payment shall be acceptable.
- 4) Financial bids of only those tenderers who have successfully completed atleast 3 similar works each costing not less than 40%, 2 works each costing not less than 60% or single work of 80% value of tender in last 5 financial years and current financial year of submission of bids shall be considered. Tenderer shall have to submit proof of having successfully completed requisite number of works of specified amount by depositing requisite documents at stipulated time mentioned above.
- 5) Original Equipment Manufacturers / Authorized Dealers / Manufacturers are eligible to quote rates for work. The submission of requisite proof must be attached at the time of submission of tenders. The authorized dealer should submit authority letter of their manufacturer, to quote the rates on their behalf failing which tender is liable to be rejected.
- 6) Any corrigendum and addendum will be displaced only on website <http://etenders.hry.nic.in> or [hpaharyanapolice.gov.in](http://hpaharyanapolice.gov.in).
- 7) The Director, Haryana Police Academy, Madhuban, Distt. Karnal reserves the right to accept or reject any tender without assigning any reason.

## **OTHER TERMS AND CONDITIONS**

1. The rates must be inclusive of GST, all taxes including Freight etc. F.O.R. at Police Complex, Madhuban.
2. The Financial bid/s of only those bidders/ items will be opened who qualify on the basis of their Technical Bids.
3. The offer without prescribed earnest Money, tender Fee & E-Service fee is liable to be summarily rejected.
4. The quantity of material can be increased or decreased.
5. The specifications of material are mentioned in the DNIT. However no material beyond approved specifications will be accepted.
6. The whole work/ material carries a Guarantee / Warrantee of 6 (Six) years.
7. The firm/Dealers shall submit a certificate that the firm is not black listed by any Govt. department, nor any criminal case/ complaint has been registered against him.
8. The successful tenderer shall be required to complete the supply and installation work within stipulated period after issuance of Supply Order / Allotment Letter. The 70% payment will be released after supply of material and balance 30% payment will be released after successfully installation and testing as per satisfaction of intending authority.
9. The successful tender at the time of allotment alongwith Contract Agreement will have to submit Bank Guarantee / FDR having value of 10% of contract / Supply Order with a validity of 6 (Six) Years + 45 days. The same will be returned after successful completion of Guarantee / Warrantee Period of 6 (Six) Years.
10. The ordered stock will have to be offered by the supplier for inspection in one or two lots as decided by the Director, Haryana Police Academy, Madhuban at one place in the premises of suppliers within **5 days** of the issue of supply order failing which the earnest money/security will be forfeited. The extra cost, if any incurred shall be recovered from the suppliers. Supplies of approved stocks will have to be made within stipulated period from the issuance of dispatch instructions. **In case the supply not made by the supplier within stipulated delivery period, the belated supplies have to be accepted subject to levy of penalty @ 0.50% per day recoverable on the value of material supplied late.**
11. The firm will have to provide contact detail of their Service Centre / Service Engineer and in case of any complaint, the same must be attended within 48 hours otherwise the same will be rectified on the risk and cost of the firm and the same will be deducted from his pending dues.
12. In case, the material offered for inspection by the firm fails to meet the specifications stipulated in NIT/Order/Contract and the samples are rejected by the Inspecting Committee, the EMD deposited by the firm will be forfeited and the Director, HPA, Madhuban will be free to procure material from the second lowest (L-2) on the risk and cost of L-1 agency. The firm will also be liable for penal action including forfeiture of security, risk purchase, debarring/ blacklisting in future, and no further opportunity for inspection would be provided to the supplier firm.
